It has been an interesting couple of months as we navigate our new norm.

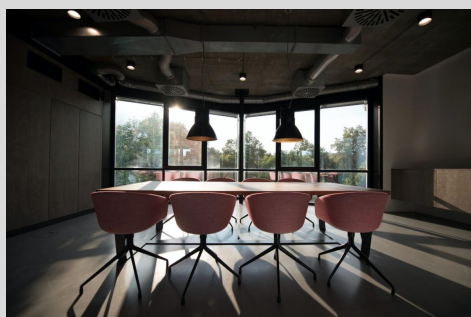

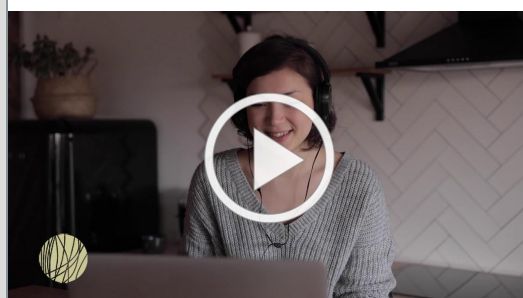


### COVID-19: Update for QLD Churches (Easing restrictions)
